

## Contract Agreement

**THIS AGREEMENT**, made this 30<sup>th</sup> day of *January, 2018* between *Municipal Government of Irosin, Sorsogon* (hereinafter called the "Entity") and *Grelips Construction & Development of Washington Drive, Brgy. 8, Legazpi City* (hereinafter called the "Contractor").

**WHEREAS**, the Entity is desirous that the Contractor execute *Irosin Lake Improvement (INFR-14-2017)* (hereinafter called "the Works") and the Entity has accepted the Bid for *Two Million Four Hundred Sixty Nine Thousand Nine Hundred Ninety Two Pesos and Nineteen Centavos (P 2,469,992.19)* by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

### **NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
